



MEMORANDUM OF UNDERSTANDING BETWEEN BOJJAM NARASIMHULU PHARMACY COLLEGE FOR WOMEN AND EDUVENTURE CAREERS OVERSEAS EDUCATION, MUMBAI

This Memorandum of Understanding is made and executed on this 28th day of July 2023 at Hyderabad, Telangana – 500063, between Eduventure Careers Overseas Education, represented by Mrs. Sunita Vinod Kotamarthi, situated at Office No. 303, 3rd Floor, Options Primo, MIDC, Near Passport Office, Mumbai – 400093 (hereinafter referred to as 'Eduventure Careers'), and Bojjam Narasimhulu Pharmacy College for Women, represented by the Principal, Dr. P Mani Chandrika, situated at Road Number 2, Vinayak Nagar, Vani Nagar, Saroor Nagar West, Saidabad, Hyderabad, Telangana 500059 (hereinafter referred to as the ('BNPCW')).

I. PREAMBLE

WHEREAS, Bojjam Narasimhulu Pharmacy College for Women (BNPCW) approached Eduventure Careers Overseas Education (EC) to conduct regular Placement Officers activity, to recruit students for the Universities represented by Eduventure Careers.

3. Will provide requisite resources and support to conduct counseling activities for BNPCW students to EC.
4. Will provide a notice board to display information about the various educational programs conducted by the universities EC represents.
5. Will authorize to conduct meetings for students and parents of BNPCW on the request of EC.
6. Will provide a suitable counseling space inside the premises of BNPCW to counsel students and parents of BNPCW students.

IV. RESPONSIBILITIES OF EDUVENTURE CAREERS

1. Eduventure Careers will provide the required administration.
2. Eduventure Careers will depute a trained Counselor for BNPCW Counseling once in two weeks.

3. EDUVENTURE CAREERS will be responsible for ensuring that all the necessary records are captured and stored on a timely basis with a copy to BNPCW.
4. Eduventure Careers will depute a person as Head of Administration from its end to oversee the entire operations on a periodic basis.
5. Eduventure Careers will conduct regular seminars, webinars, and workshops in the college premises.
6. Eduventure Careers will provide periodic updates and details of the students applying for studies abroad on a periodic basis to the Coordinator from BNPCW.
7. Eduventure Careers shall obtain prior written consent for all promotional activity done on BNPCW premises.
8. Eduventure Careers shall strictly abide by the rules and regulations of BNPCW at all times.
9. Eduventure Careers shall be wholly responsible for any complications/contingencies arising during/after students join the collaborating foreign university.

V. USE OF INTELLECTUAL PROPERTY

All other intellectual property used in the implementation of the MOU will remain the property of the party that provided it. This property can be used by either party for purposes covered by the MOU but consent will be obtained from the owner of the property before using it for purposes not covered by the MOU.

VI. EFFECTIVE DATES AND AMENDMENTS

This MOU shall take effect upon signing by both parties and shall remain in effect for a period of three (3) years from that date unless earlier terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.

The MOU may be renewed at the end of this period by mutual written agreement by both parties.

The provisions of this MOU may only amended or waived by mutual written agreement by both parties.

Any Party may terminate this MOU and any related agreement at any time and for any reason by giving thirty (30) days prior written notice to the other party.

The individuals signing this MOU on behalf of their respective entities represent and warrant (without personal liability therefor) that upon the signature of each, this MOU shall have been duly executed by the entity each represents.

VII. DISPUTE RESOLUTION

The Partners hereby agree that, in the event of any dispute between the Partners relating to this Agreement, the Partners shall first seek to resolve the dispute through informal discussions. In the event any dispute cannot be resolved informally within sixty (60) calendar and consecutive days, the Partners agree that the dispute will be negotiated between the Partners through mediation if the Partners can agree on a mediator. Any unresolved disputes will be referred to the President/Director/Chairman of BNPCW, and the decision shall be binding on both the parties without any monetary and legal implications.

VIII. ENTIRETY

This Agreement, including all Annexes, embodies the entire and complete understanding and agreement between the Partners, and no amendment will be effective unless signed by both Partners.



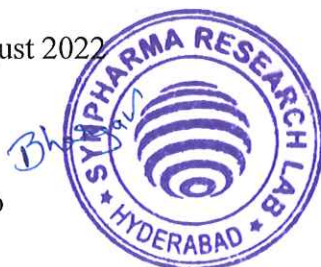

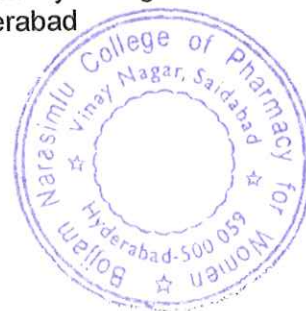
